# Minutes of NEERS Business Meeting October 21, 1994, Orleans, MA, Jail House Tavern Robert Buchsbaum, Secretary-Treasurer

- 1. The Secretary and Treasurer's Reports were read by Robert Buchsbaum and approved without discussion.
- 2. ERF 1997. President Berounsky introduced Jonathon Garber from the EPA's Narragansett Laboratory, who is the organizer for the ERF meeting to be held in 1997 in Providence. He is looking for volunteers for the eight local committees, including scientific, social, etc. Jonathon is both the chief local organizer and the scientific organizer. He stressed that there are two guiding principles: (a) having a first class scientific meeting and (2) making money for ERF.

A number of NEERS members expressed interest in helping. The question arose whether people could get some kind of travel support to attend committee meetings.

Students planning to present a paper at the ERF meeting should enter the NEERS lottery for the student travel award, \$300 to go toward expenses. The deadline is the same as the deadline for the ERF abstract. ERF also has a student travel award that is selected by lottery. Students can win both simultaneously (if their very lucky).

### 3. Constitutional Changes.

Creating a separate Secretary and Treasurer as desribed in the July issue of NEERS News. Rich Orson moved to accept the proposed changes and it was seconded.

President Berounsky added a friendly amendment - A minimum of three students were required to compete for a Ketchum or Rankin Prize in order for it to be given out in any meeting. This was discussed at length as ff.

Ted Loder - This would create the problem of the student who expected a competition but through no fault of his/her

Linda Birely - AFS will give out a grad student paper award with only one student candidate as long as the paper is acceptable.

Julie Rankin suggest that we should have at least two students competing.

Tom Duncan stated that this should not be an attendence award, but should be a competition. If the award was not given in at one meeting, perhaps the money could be rolled over into a bigger prize at the next meeting.

Linda Deegan said that the award should be given out as long as there was a good paper. It is possible that NEERS does not have to give out the prizes even if there are 12 students, if the judging committee decides that none of the papers were worthwhile.

Heidi Hoven, presenting a grad student perspective, said that it would be too much of a blow to a student if they were the only ones to show up but werec not given the prize if they happen to have had a bad day.

Sandy MacFarlane pointed out that in some years we have to beat the bushes to get three students for each prize. Marshall Pregnall said that they did a good job of soliciting students for this year's awards and still have only limited participation.

Fall 96 - Election meeting so needs to be in a central location, such as Massachusetts

Spring 97 - perhaps in Maine

Volunteers are needed to organize meetings. President Franz pointed out that there are no costs to the host institutions.

## 8. NEERS 25th Anniversary.

Veronica Berounsky read a FAX from Ed and Kathy Rhodes, NEERS members who live in Chile, wishing NEERS a happy 25th Anniversary. Ed and Kathy are forming a new estuarine research society they are naming CHEERS.
